Waiver of Liability and Release

For and in consideration of the undersigned participant's ("Student-Athlete") registration with Fight For Me, Inc d/b/a Pro Process Academy ("PPA") and being allowed to participate in events and member activities, Student-Athlete and the parent(s) or legal guardian(s) of Student-Athlete hereby and forever waive, release and relinquish any and all claims for liability or causes of action, including but not limited to for personal injury, property damage or death occurring to Student-Athlete or Student-Athlete's parent(s) or legal guardian(s) against PPA or PPA's officers, agents, servants, employees and volunteers (collectively, "Releasees"), arising out of participation in, in connection with, or in any way associated with PPA's events, sports, and/or activities incidental thereto, whenever or however they occur, and by this agreement any such claims, rights, and causes of action that Student-Athlete and/or Student-Athlete's parent(s) or legal guardian(s) may have are hereby and forever waived, released and relinquished, and Student-Athlete and Student-Athlete's parent(s)/guardian(s) do so on behalf of their heirs, executors, administrators and assigns.

Student-Athlete and Student-Athlete's parent(s)/guardian(s) acknowledge, understand and assume all risks relating to events or sports participation and activities incidental thereto, and understand that activities incidental thereto involve risks to Student-Athletes and Student-Athlete's parent(s)/guardian(s)/ person(s) including bodily injury, partial or total disability, paralysis and death, and damages which may arise therefrom and that the undersigned parent(s) or legal guardian(s) has full knowledge of said risks. These risks and dangers may be caused by the negligence of the Student-Athlete, Student-Athlete's parent(s)/guardian(s) or the negligence of organizations, their affiliates or members, event hosts, other participants, other parents and legal guardians, coaches, officials, sponsors, advertisers, owners and operators of the premises used to conduct any event and each of them, their officers, directors, agents and employees (collectively, "Additional Releasees"), and include risks arising from the conditions and use of facilities and related premises. The undersigned parent(s) or legal guardian(s) further acknowledges that there may be risks and dangers not known to anyone or not reasonably foreseeable at this time.

Student-Athlete and Student-Athlete's parent(s)/guardian(s) acknowledge, understand and assume the risks, if any, arising from the conditions and use of facilities and related premises, whether as a participant or a spectator, including without limitation, the risks involved with participating in PPA's activities. Student-Athlete and Student-Athlete's parent(s)/guardian(s) further acknowledge and understand that included within the scope of this waiver and release is any cause of action (including any cause of action based on negligence) arising from the performance, or failure to perform, maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said facilities, for negligent selection of certain Additional Releasees, or negligent supervision or instruction by Additional Releasees.

Student-Athlete and Student-Athlete's parent(s)/guardian(s) acknowledge, agree and confirm that the Student-Athlete is fit and healthy to participate in PPA's activities and that Student-Athlete has been cleared by a medical professional to participate in PPA's activities.

Student-Athlete and Student-Athlete's parent(s)/guardian(s) acknowledge that they have been provided and have read the above paragraphs and have not relied upon any representations of Releasees or Additional Releasees, that they are fully advised of the potential dangers and risks and understand these waivers and releases are necessary to allow the activities of PPA to exist in its present form.
